March 23, 2015

Minutes of Meeting of Weymouth Board of Commissioners

A meeting of the Weymouth Board of Commissioners was held on March 23rd, 2015 with Commissioners Gaudett, Frizzell and Raymond present. Chair, Commissioner Gaudett called the meeting to order at 7.00 PM .

Prior to the commencement of the regular meeting, a presentation was made by Eben Sabeau on behalf of the Weymouth Cadet Corp. They need to vacate their current location by mid April and are requesting the Village Commission to make some space available for their corps. After discussion and a tour of the lower level of the medical centre it was moved by Commissioner Frizzell, Seconded by Commissioner Raymond that the Cadets be permitted to use the unoccupied portion of the lower level including one of the two vacant store rooms, subject to provision for the proposed expansion on the VON rental space.
